NOT SHOWING WORK OR STEPS

SOLUTION: THE DERIVATIVE $f'(x) = 6x + 2$. AT $x=4$, $f'(4) = 6(4) + 2 = 24 + 2 = 26$. CORRECT ANSWER: A) 26.

SHORT ANSWER: CALCULATE THE AREA OF A TRIANGLE WITH BASE 10 UNITS AND HEIGHT 7 UNITS.

SOLUTION: AREA = $(1/2) \times \text{BASE} \times \text{HEIGHT} = (1/2) \times 10 \times 7 = 35$ SQUARE UNITS.

TRUE OR FALSE: THE SUM OF THE INTERIOR ANGLES OF A HEXAGON IS 720 DEGREES.

SOLUTION: TRUE. THE FORMULA FOR THE SUM OF INTERIOR ANGLES OF AN n -SIDED POLYGON IS $(n-2) \times 180$. FOR HEXAGON, $(6-2) \times 180 = 720$ DEGREES.

PROBLEM SOLVING: A CAR TRAVELS 120 MILES IN 2 HOURS. WHAT IS ITS AVERAGE SPEED IN MILES PER HOUR?

SOLUTION: AVERAGE SPEED = TOTAL DISTANCE / TOTAL TIME = 120 MILES / 2 HOURS = 60 MPH.
