5. **QUESTION:** WHAT SHOULD YOU DO WHEN APPROACHING A SCHOOL BUS WITH FLASHING RED LIGHTS?

**ANSWER:** STOP AND DO NOT PROCEED UNTIL THE LIGHTS STOP FLASHING AND THE BUS MOVES.
