UNDERSTANDING THE "AM I SPED TEST" CONCEPT

COMMON REASONS FOR REQUESTING AN EVALUATION

PARENTS, TEACHERS, OR GUARDIANS MAY REQUEST A SPECIAL EDUCATION EVALUATION WHEN A STUDENT EXHIBITS:

- DIFFICULTY KEEPING UP WITH ACADEMIC TASKS
- STRUGGLES WITH COMMUNICATION OR SOCIAL INTERACTION
- BEHAVIORAL PROBLEMS AFFECTING LEARNING
- PHYSICAL IMPAIRMENTS OR HEALTH ISSUES IMPACTING EDUCATION
- DEVELOPMENTAL DELAYS OR DISABILITIES DIAGNOSED PREVIOUSLY

THE PURPOSE OF SPECIAL EDUCATION TESTING

SPECIAL EDUCATION TESTING SERVES TO IDENTIFY WHETHER A STUDENT HAS ONE OR MORE DISABILITIES THAT ADVERSELY AFFECT THEIR EDUCATIONAL PERFORMANCE. THE GOAL IS TO DETERMINE ELIGIBILITY FOR SPECIAL EDUCATION SERVICES AND TO DEVELOP AN INDIVIDUALIZED EDUCATION PROGRAM (IEP) TAILORED TO THE STUDENT'S UNIQUE NEEDS. THIS EVALUATION PROCESS ENSURES STUDENTS RECEIVE APPROPRIATE SUPPORT TO SUCCEED ACADEMICALLY AND SOCIALLY.

ENSURING APPROPRIATE EDUCATIONAL PLACEMENT

TESTING HELPS EDUCATORS AND PARENTS MAKE INFORMED DECISIONS ABOUT THE MOST SUITABLE LEARNING ENVIRONMENT. IT PROVIDES DATA TO DECIDE IF A STUDENT REQUIRES SPECIALIZED INSTRUCTION, ACCOMMODATIONS, OR RELATED SERVICES SUCH AS SPEECH THERAPY OR COUNSELING.

THE SPECIAL EDUCATION EVALUATION PROCESS

PHYSICAL AND HEALTH ASSESSMENTS

MEDICAL OR OCCUPATIONAL THERAPY EVALUATIONS MAY BE CONDUCTED TO ASSESS MOTOR SKILLS, SENSORY PROCESSING, OR OTHER PHYSICAL CONDITIONS AFFECTING EDUCATIONAL PERFORMANCE.

LEGAL RIGHTS AND PROTECTIONS DURING SPED TESTING

ONGOING MONITORING AND REEVALUATION
