HISTORICAL CONTEXT OF CARRIE CHAPMAN CATT'S TEXTS

Socio-Political Environment

Pathos: Emotional Appeals

Logos: Logical Argumentation

Themes and Motifs in Carrie Chapman Catt's Texts

Equality and Justice
