CONSTITUTIONAL PRINCIPLES AND FOUNDATIONS

INSTITUTIONS OF NATIONAL GOVERNMENT

THIS SECTION EXPLORES THE STRUCTURE AND FUNCTIONS OF CONGRESS, THE PRESIDENCY, THE FEDERAL BUREAUCRACY, AND THE FEDERAL COURTS. QUESTIONS TEST KNOWLEDGE OF LEGISLATIVE PROCESSES, EXECUTIVE POWERS, JUDICIAL REVIEW, AND THE RELATIONSHIP BETWEEN THESE BRANCHES.

PUBLIC POLICY AND CIVIL RIGHTS

STUDENTS MUST BE FAMILIAR WITH THE POLICY-MAKING PROCESS, DOMESTIC AND FOREIGN POLICY ISSUES, AND LANDMARK CIVIL RIGHTS LEGISLATION. THIS INCLUDES UNDERSTANDING THE IMPACT OF SUPREME COURT RULINGS ON CIVIL LIBERTIES AND CIVIL RIGHTS.

EFFECTIVE STRATEGIES FOR MULTIPLE CHOICE PRACTICE

PROCESS OF ELIMINATION

WHEN UNCERTAIN ABOUT AN ANSWER, ELIMINATING CLEARLY INCORRECT OPTIONS INCREASES THE CHANCES OF SELECTING THE CORRECT ONE. THIS TECHNIQUE IS PARTICULARLY USEFUL IN MULTIPLE CHOICE FORMATS WHERE DISTRACTORS ARE DESIGNED TO CONFUSE TEST-TAKERS.

PRACTICE UNDER REALISTIC CONDITIONS
