THE BRANCHES OF GOVERNMENT

STRATEGIES FOR ANSWERING MULTIPLE CHOICE QUESTIONS

ELIMINATING WRONG ANSWERS

NARROWING DOWN CHOICES BY ELIMINATING OBVIOUSLY INCORRECT OPTIONS INCREASES THE PROBABILITY OF SELECTING THE CORRECT ANSWER. THIS TECHNIQUE IS ESPECIALLY USEFUL WHEN UNSURE ABOUT THE BEST CHOICE AMONG MULTIPLE CLOSE OPTIONS.

USING CONTEXTUAL KNOWLEDGE

APPLYING KNOWLEDGE OF CONSTITUTIONAL PRINCIPLES, CASE LAW, AND GOVERNMENT FUNCTIONS TO THE QUESTION CONTEXT AIDS IN SELECTING THE MOST APPROPRIATE ANSWER. SOMETIMES, QUESTIONS INCORPORATE SCENARIOS REQUIRING ANALYTICAL APPLICATION RATHER THAN MERE RECALL.

TIME MANAGEMENT

ALLOCATING TIME WISELY ACROSS QUESTIONS PREVENTS RUSHING AND CARELESS MISTAKES. IT IS ADVISABLE TO ANSWER EASIER QUESTIONS FIRST, THEN REVISIT MORE CHALLENGING ONES. THIS APPROACH ENSURES MAXIMIZED SCORING WITHIN THE TEST'S TIME CONSTRAINTS.
