Westward Expansion and Sectional Tensions

This decision invalidated key legislative compromises and outraged many in the North, further polarizing the country. The ruling intensified sectional tensions and undermined efforts to find a political solution to the slavery issue.

The Election of 1860 and Secession

The election of Abraham Lincoln in 1860, representing the anti-slavery Republican Party, was the final trigger for southern states to secede from the Union. Lincoln's victory, without carrying a single southern state, convinced many southerners that their interests would no longer be protected within the United States. Between late 1860 and early 1861, eleven southern states formed the Confederate States of America, setting the stage for armed conflict.

The Civil War: Causes and Major Developments

The war also brought significant social upheaval, including increased roles for women and changes in the southern economy.

Reconstruction and Its Challenges

The final part of AP US History unit 5 examines the period after the Civil War, when the nation struggled to rebuild and integrate the formerly Confederate states. Reconstruction was marked by political conflict,

social change, and efforts to secure rights for newly freed African Americans.

Presidential and Congressional Reconstruction

The passage of the Reconstruction Acts placed southern states under military rule and required them to ratify the 14th Amendment and guarantee voting rights to African American men.

Amendments and Civil Rights

During Reconstruction, three critical constitutional amendments were ratified:

- **13th Amendment (1865):** Abolished slavery throughout the United States.
- **14th Amendment (1868):** Granted citizenship and equal protection under the law to all persons born or naturalized in the U.S.
- **15th Amendment (1870):** Prohibited denying the right to vote based on race, color, or previous condition of servitude.

These amendments laid the legal foundation for civil rights, though their enforcement was inconsistent and often resisted in the South.

Resistance and the End of Reconstruction

Reconstruction faced fierce opposition from many white southerners, who formed groups such as the Ku Klux Klan to intimidate African Americans and Republican leaders. Economic difficulties, political compromises, and waning northern support eventually led to the withdrawal of federal troops in 1877, effectively ending Reconstruction and ushering in an era of segregation and disenfranchisement.
