OLIGARCHY

OLIGARCHY REFERS TO A GOVERNMENT CONTROLLED BY A SMALL GROUP OF PEOPLE, OFTEN BASED ON WEALTH, FAMILY TIES, OR MILITARY CONTROL. DECISIONS ARE MADE TO BENEFIT THE RULING GROUP RATHER THAN THE GENERAL POPULATION.

OTHER GOVERNMENT FORMS
