- THE AMERICANS WITH DISABILITIES ACT (ADA) – ENSURES EQUAL ACCESS AND PROHIBITS DISCRIMINATION AGAINST INDIVIDUALS WITH DISABILITIES
- THE AGE DISCRIMINATION IN EMPLOYMENT ACT (ADEA) – PROTECTS WORKERS AGED 40 AND OVER FROM EMPLOYMENT DISCRIMINATION
