THIS APPROACH ASSUMES THAT TRUTH IS A PROPERTY OF A COHERENT AND CONSISTENT SYSTEM OF PROPOSITIONS RATHER THAN ISOLATED STATEMENTS.

COHERENCE VERSUS CORRESPONDENCE
