BOXES 16-20: STATE AND LOCAL TAX INFORMATION

THESE BOXES REPORT WAGES AND TAXES WITHHELD FOR STATE AND LOCAL JURISDICTIONS. THE FINE PRINT EXPLAINS HOW TO HANDLE MULTI-STATE EMPLOYMENT OR LOCAL TAX CODES, WHICH CAN AFFECT STATE INCOME TAX RETURNS.

IMPORTANCE OF THE FINE PRINT FOR TAX FILING
